# Contract - Rules

## ARTICLE 1 :

### Organisation

Alain Gestin Organisation Event International organizes the extreme runner race: the 1200 (km) from October 27th to November 20th 2022 in the Mauritanian desert.

### General descriptions

The 1200 (km) is a nonstop, free speed and individual running race of 1200 km: with 59 CP every 20km or so. At each CP the runner checks in on the piece of paper they will be given. The overall race time is 468 hours at the most. You will need your own GPS device (you will enter waypoints on the file provided by the Organisation).

### Feature

You are supposed to bring your own solid food for the whole race but drinks are provided by the Organisation at each CP (water / Coke).

Your food will be dropped off by the Organisation at each CP before the race, and your dropbags in the even CP (CP2, 4, 6, 8, etc...). 28 dropbags in total will be dropped off by the Organisation. A meal (couscous vegetables or pasta) will be provided by the Organisation every 100 km for all runners.

## ARTICLE 2 :

### General notice

The 1200 (km) will take place in accordance with the event's rules which all the competitors abide by when registering.

## ARTICLE 3 :

### Competitors' admission: requirements and conditions.

Anyone who is 18 and over can participate in the running, regardless of your gender and nationality, if you meet the requirements of these rules and provide a medical certificate stating that you are physically able to take part in the event and that you have done an electrocardiogram in less than 60 days prior to the departure. The Organisation reserves the right to deny the registration of a runner without having to explain why.

## ARTICLE 4

### A) The event - Programme

You will find further information in the downloadable race file.

### B) Food and drinks during the running

At each CP, every 20km, 3L of bottle water and Coke are available. You are supposed to bring your own solid food. **DO NOT FORGET YOUR COFFEE PODS, TEA AND SUGAR.** Your CP bags will be dropped off by the Organisation at the even CP.

### C) Sleeping bag

Having a sleeping bag is mandatory and must be in your backpack or camel back so you can use it at all times, as well as your survival blanket and your pharmacy kit.

## ARTICLE 5 :

**Ranking** Every participant enters the competition individually. The individual ranking of the event lumps all categories together. SCRATCH ranking only.

## ARTICLES 6 :

**Awards** Each competitor who gets in the ranking is given a personalized certificate as well as a medal, a "Finisher" T-shirt and a "Finisher" jacket which will be sent within 30 days after the race.

## ARTICLE 7 :

### Responsibility

All runners are well aware of the possible risks associated with the race. The Organisation accepts no responsibility with regard to potential accidents due to bad health or a personal imprudent initiative from a runner. The Organisation cannot assume the individual responsibility of each participant.

## ARTICLE 8 :

### A) Medical team

A medical team is available to the runners throughout the race and intervenes on the circuit as well as at the finish zone if needed.

**Warning: runners who have been on a drip under the supervision of the medical team will be disqualified from the race, as soon as the runner gets his first perfusion. Each runner must be able to do their own footcare during the race. Therefore the runner should have their own pharmacy kit, which will be checked by the Organisation before the departure, in their backpack at all times.**

### B) Communication

Each runner will be equipped with a satellite GPS tracker device provided by the Organisation in order to know the position of the runners during the race.

**C) The medical team has the right to exclude a competitor from the race who appears unable to run further and/or needs survival medical treatment.** They make sure the runner is repatriated from a control point or the nearest medical care center.

## ARTICLE 9 :

### Withdrawing from the race

If you quit the race or have been disqualified you will be allowed to continue the race in the trekking category. At the arrival, you will be given a certificate stating the number of kms you ran during your race days.

## ARTICLE 10 :

### Insurance

You are required to have your own medical insurance, repatriation and cancellation insurance and liability insurance. It is requested that you give written proof to the Organisation 30 days prior to the start of race.

## ARTICLE 11 :

### Cancellation

Cancellation requests have to be sent via registered letter with recorded delivery. If you request a refund, we can send the invoice of your registration to your insurer with all rights and privileges pertaining thereto. In case of cancellation due to force majeure, you may use the amount you paid as a credit note within 2 years for any race from Alain Gestin Organisation. The Organisation reserves the right to hold the running race in a different country under the same aforementioned conditions.

## ARTICLE 12 :

### Registration

For the total amount of your registration there are 2 payment options. **If we do not receive the total amount 30 days before the departure, the Organisation reserves the right to cancel the reservation and will not provide indemnity.**

## ARTICLE 13 :

### Companion

If you are interested in following the race as a non runner participant you can register as a companion. You will follow the race in one of the Organisation's cars. As a companion you will have to be self-sufficient with your backpack at your disposal. The service is similar to the runners'.

## ARTICLE 14

### Equipment

All runners must have the appropriate equipment based on the generic list (race equipment, administrative documents) provided by the Organisation which you will receive as soon as you return your commitment. The Organisation will check them the day before the departure.

## ARTICLE 15 :

For safety or technical reasons, the Organisation reserves the right to make changes during the running event, regarding the place and country where the event will take place, if necessary.

## ARTICLE 16 :

### Use of images

**Alain Gestin Organisation reserves all exclusive rights to the use of runners' pictures during the event.**

All videos and pictures from the event must be for private use only, which applies to the runners, the companions and the staff, unless special consent or accreditation from Alain Gestin Organisation was given.
